This privacy notice discloses the privacy practices for **Portable Solar LLC (DBA: Sol-Ark)** and our website; <https://www.Sol-Ark.com> This privacy notice applies solely to information collected by this website, except where stated otherwise. It will notify you of the following:

- What information we collect;
- With whom it is shared;
- How it can be corrected;

### **Information Collection, Use, and Sharing**

We are the sole owners of the information collected on our website, Social Media accounts and our office records for business transactions. We only have access to/collect information that you voluntarily give us via email or other direct contact from you. We will not sell or rent this information to anyone, ever.

We will use your information to respond to you, regarding the reason you contacted us. We will not share your information with any third party outside of our organization, other than as necessary to fulfill your request, e.g., to ship an order.

Unless you ask us not to, we may contact you via email in the future to tell you about specials, new products or services, or changes to this privacy policy.

### **Your Access to and Control Over Information**

### **Pop-Up Form**

To gain information from us, you may first complete the Pop-Up form. This information is used to contact you about the products/services on our site in which you have expressed interest. At your option, you may also provide additional information, as necessary.

## **Orders**

We request information from you on our order form depending on your needs. To buy from us, you must provide contact information (like name and shipping address) and financial information (like credit card number, expiration date). This information is used for billing purposes and to fill your orders. If we have trouble processing an order, we'll use this information to contact you. We DO NOT Store Credit Card Information for future use.

## **Sharing**

We Do not share your information with any partners. I few decide to do so in the future, we will contact you and ask you to opt in or opt out.

*And/or:*

We use an outside shipping company to ship orders, and a credit card processing company to bill users for goods and services. These companies do not retain, share, store or use personally identifiable information for any secondary purposes beyond filling your order.

*And/or:*

We partner with another party to provide specific services. When the user signs up for these services, we will share names, or other contact information that is necessary for the third party to provide these services. These may be installers who you may have requested for your case.

## **Security**

We take precautions to protect your information. When you submit sensitive information via the website, your information is protected both online and offline.

Wherever we collect sensitive information (such as credit card data), that information is encrypted and transmitted to us in a secure way. You can verify this by looking for a closed lock icon at the bottom of your web browser or looking for "https" at the beginning of the address of the web page.

The computers/servers on which we store personally identifiable information are kept in a secure environment.
